**OTHERS TERMS & CONDITIONS**

1. The above work contract is purely on contractual and bi-lateral basis. Initially, the work contract will be for a period of one year, but may be extended further subject to requirement of the Institute and based on performance of the work.
2. An Amount of **Rs. 12500/- (Rs. Twelve thousand five hundred only)** will be paid per month in the form of **consolidated monthly package** on submission of monthly bill of services rendered and may be enhanced by an amount not exceeding 10% of preceding year's consolidated package amount subject to the satisfactorily performance of work under the above work contract.
3. **Age 35 to 55 years.** In case any of the personnel so provided is not found suitable by the Institute, the Institute shall have the right to disqualify the candidate.
1. Canvassing, in any form, will disqualify the candidate.
2. Bring one copy of Bio-data duly signed, original certificates and the attested photocopies of all the required certificates from matriculation onwards, an attested copy of recent passport size photograph and discharge certificate issued by the appropriate authority.
3. No bonus shall be payable to you.
4. No terminal leave shall be admissible on termination of the contract.
5. TDS on income, if due shall be recovered from package payable to you.
6. In case uniform/livery is compulsory, you will have to comply the instructions, for which no extra payment will be made by this Institute.
