7. This Institute reserves the right to reject any or all quotation(s) received without assigning any reasons thereof.
8. Income Tax will be deducted by this Institute as per rule.
9. The contractor will pay the Service Tax, if applicable at his own level/responsibility.

The Contractor/Contract Agency will discharge all their legal obligation of their workers in respect of their wages and other service conditions and shall also comply with all the rules and regulation and provision of law in force that may be applicable to them from time to time viz. Statutory obligation under Contract Labour (Regulation and Abolition) Act, 1970, Minimum Wages Act, Workmen's Compensation Act, EPF and M.P. Act and Industrial dispute Act etc.
