

2. There should be no cutting/overwriting. The cutting, if any, should be duly attested /signed, overwritten figures will not be considered. In all matter or disputes, the decision of the Director of this Institute shall be final binding on the bidders.
3. Bid should be sent in a sealed cover indicating the words. **"Sealed bid for sale of Paddy Grain Variety Basmati-1509 & Variety PB-124 file no.3/Pur/RSN/47** with last date for receipt **10.11.2017 upto 2.30 p.m.** and will be opened on same date i.e. **10.11.2017 at 2.30 p.m.** Sealed bid received is an unsealed cover or received after due date and those ambiguous are liable to be rejected.
4. This Institute reserves the right to reject any or all bid(s) received without assigning any reasons thereof.
5. The successful bidder has to pay sales tax + VAT and market fee etc. if any as applicable and also if any permission/license from any Deptt. Concerned.

8. The lifting of the Paddy is to be done in such a way that there should be no loss to the INSTITUTE PROPERTY. If any loss occurs it will be borne by the concerned party.
9. The lifting of the Paddy to be started only after full payment is made and total removal of the paddy will have to be made within 10 days after payment. For the delay beyond 10 days amount of Rs.500/- per day will be charges.
10. Gate pass will be issued to the contractor to whose name the final bid accepted by CIRB authority.
11. During the lifting of paddy care should be taken to avoid any damage electric wire, building & any other structure of CIRB, Sub-campus, Nabha, if any damage that will be made good from the concerned contractor.
12. Material will be allowed during 9.00 a.m. to 5.00 p.m.
13. The arrangement of labour and cost for filing, lifting & transportation etc. will be responsibility of the bidder.

14. Details of Labour employed i.e. name and total number for lifting paddy will have to be provided to CIRB in written.
15. During the lifting of paddy if any mis- happening happened with labour whole responsibility will be on concerned contractor.
