1. The material should be free from adulterants, foreign material, insects, pests, fungus infestation, rancid odour decolouration, sharp objects and urea

2. (a) Pro-rata cut will be applicable in case of deviations (within acceptable limits) from the prescribed specifications with deduction at the rate given below:

Moisture, CP, CF & AIA : 1% per unit  
Oil : 3% per unit

3. Pro rata cuts will be additive for all parameters

\*No premium will be provided on higher percentage of any specified item; except the each unit of extra oil above the minimum requirement can compensate (less) CP up to 2% point.
