### TITLE:-DUNG COLLECTION, TRANSPORTATION AND CLEANLINESS IN BUFFALO FARM OF CIRB, NABHA

**Work:**-Dung collection from buffalo enclosures of herd of around 400-550 animals, filling in trolleys and transportation to the pits/fields in the range of 2-3 km. Daily as given below:-

6.	Bull Pens	30x9.5 feet	14	Dung collection Manger, water trough cleaning and lifting any leftover.
7.	Experimental area	140x50 feet	1	Dung collection and cleaning with broom.

#### Terms & Conditions:-

- 1. Tractor, trolley and driver will be provided by the work shop section of CIRB.
- 2. Other implements/material for dung collection, filling etc. such as belcha, phawra, tasla, tokra, brooms etc. will be of the contractor.
- 3. Partially cleaned area will be assumed as unclean and for unsatisfactory work, proportionate amount of cut/penalty will be imposed from the final bill.
- 4. Cleaning of mangers and water trough daily.
- 5. Cleaning/dung collection/washing in such a manner that channel should not choke.
- 6. Contractor must ensure that persons engaged for the work should not harm animals sheds and other property of the institute in any way.
- 7. The contractor will follow all labour related norms fixed by labour department from time to time.
- 8. Contractor will also submit undertaking alongwith the bill that all the dues and wages are given to engaged persons through cheques, timely.

#### Annexure-II

<u>Title:</u>-Distributions of feed & fodder daily to animal herd of CIRB, Subcampus, Nabha(Pb.)

#### (Period June, 2017 to May, 2018)

- 1. Distribution of concentrate ration (as per norms i.e. varying from 10 to 15 qtls. Daily) to different categories of buffaloes i.e. 400-500, as per requirement or as directed by the supervisor/Incharge, Animal Farm. Concentrate ration will be distributed after proper cleaning of mangers i.e. after removal of any leftover of previous day before 10.00 a.m.
- 2. Fodder distribution (chaffed/un-chaffed), silage/karbi hay/dry bhusa, as per the requirement (varying from 110-170 qtls.)daily to the herd of 400-550 animals (Bulls, milch buffaloes, dry buffaloes, heifers, growing males and females) in different sheds/location at different times.
- 3. Fodder distribution in such a manner that wastage should be avoided/minimized.
- 4. Fodder, concentrate, dry straw distribution to animals will be as per instructions of supervisor/ Incharge, BPM/OIC, varying from time to time.
- 5. Normal time of fodder/Ration distribution will be from 8.00 a.m. to 6.00 p.m. depending up on season.
- 6. Material required (if any) for supply of fodder/silage to mangers, except tractor & trolley with driver, will be sourced by the contractor.
- 7. For unsatisfactory work proportionate cut & penalty will be imposed from the bill.
- 8. The contractor will follow all norms fixed by labour department for welfare of persons engaged.
- 9. Contractor will also certify on the bill that all the dues and wages are given to engaged persons through cheque, timely.
